The following positions shall be paid a monthly mileage allowance, based on the listed miles per month at the adopted IRS rate. Monthly mileage rates will be updated on July 1 of each year to reflect the current IRS rate. Monthly mileage is for all travel within the Fresno, Madera and Tulare County areas.
