SCHOOL HEALTH SERVICES/CHILDREN'S HEALTH CENTERS

PURPOSE: To describe the Board's philosophy relative to expanded health services in the District.

The Board supports cooperation with private and public agencies in the delivery of primary health care in targeted geographic areas using District facilities where the community has limited access to health care and where treatments for specific illnesses, diseases, and conditions are included as a part of the interagency agreement generated as part of such cooperation. Expanded health programs will be self-funded. Any Children's Health Center will require Board approval.

The provision of contraceptives is inconsistent with the Board's position specifying abstinence as the primary message to be communicated to students in its instructional programs relevant to sexual experiences for youth in the prevention of sexually transmitted diseases. Consistent with that position, the Children's Health Centers will not prescribe or distribute any type of contraceptives. Any health guidance and counseling done by the school nurses at the Children's Health Centers will be consistent with the laws.

The Board authorizes the Superintendent or designee to develop and adopt an administrative regulation setting forth procedures regarding Children's Health Centers.
