PURPOSE: To establish requirements for earning a high school diploma through Clovis Adult Education.

1.0 COURSE DISCIPLINES	
1.1 Physical Education	1.1 Two courses (20 credits) in Physical Education Unless the student has been exempted pursuant to the provisions of Education Code sections 51241, 51242 and 51246
1.2 Language Arts	1.2 Three and a half courses (35 credits) in English
1.3 Mathematics	1.3 Two courses (20 credits) in mathematics including one course with the content equivalent of Algebra 1
1.4 Science	1.4 Two courses (20 credits) in science including biological and physical sciences
1.5 Social Science	1.5 Three courses (30 credits) in social studies, including one course (10 credits) in United States History; one course (10 credits) in World History; one-half course (5 credits) in American Government; and one-half course (5 credits) in Economics
1.6 Career Planning & Vocational Preparation	1.6 Two and one-half courses (25 credits) out of the elective credits must be approved college prep courses or vocational education units
1.7 Visual or Performing Arts/Foreign Language	1.7 Two semesters (10 credits) of visual or performing arts or foreign language
1.8 Electives	1.8 Five courses (50 credits) of elective credits, excluding P.E. courses, for students who are 18 years old as of the date of enrollment at Clovis Adult Education. Two courses (20 credits) of elective credits, excluding P.E. courses, for students who are 19 years or older as of the date of enrollment at Clovis Adult Education
1.9 Dual Enrollment (SCCCD) and other official college transcripts	1.9 Students may apply community college concurrent enrollment courses to meet Clovis Adult Education graduation requirements following the Clovis Community College/CAE course articulation document. Official college transcripts can also be accepted for high school credits toward a CAE high school diploma

2.0 REQUIREMENTS	
2.1 Credit Requirements (students 19 years and older)	2.1 Completion of 180 credits of work (including maximum of two courses in P.E.), in which at least 10 credits is "in residency" at Clovis Adult Education.
2.2 Credit Requirements (students 18 years and under)	2.2 Completion of 210 credits of work (including maximum of two courses in P.E.), of which at least 10 credits is "in residency" at Clovis Adult Education.
2.3 Graduation Ceremonies	2.3 A student graduates at the time all requirements are met. Diplomas are awarded each year in June at a graduation ceremony conducted for adults who have met graduation requirements.
