SCHOOL DISTRICT****INSTRUCTION****Student Instruction and Progress****CLASS ASSIGNMENT/CALCULATING CLASS RANK**

PURPOSE: To establish procedures for class assignment and calculation of class rank.

A. Class Assignment

The Board believes that students should be assigned to courses and classrooms and/or grouped in a manner that provides an effective learning environment. The Board directs the Superintendent to establish the parameters for assigning students to specific courses and classes in an administrative regulation.

B. Calculating Class Rank

The Board acknowledges the usefulness of and authorizes a system of computing grade point averages and class ranking. The objectives are to: (1) provide information for school and District awards, and (2) provide employers and institutions of higher learning a predictive device so students are placed in the appropriate environment conducive to success. The Board recognizes the value of all curricula/subjects and wishes to honor students for their academic success. Therefore, class rank shall be computed by the grades earned in Board-approved courses.

A student's grade point average in both a non-weighted and weighted class rank shall be entered on the student record and shall be subject to board policy and applicable laws on release of student records. The weighted class rank is provided as a service to assist students in college admission but is not used within the District's system to identify valedictorian or salutatorian status. A weighted class rank may be used by individual high schools within the District to identify students for special awards of distinction.

The Board directs the Superintendent to adopt an administrative regulation to implement this policy.
