Open Enrollment Transfers - ninety percent (90%) of Permanent Design Capacity will be used to establish the school capacity for Open Enrollment Transfer Requests for elementary schools as outlined in the District's Board Policy and ninety-five percent (95%) of Permanent Design Capacity will be used for secondary schools. Other factors may include the combined capacity at educational center sites, number of students in a particular grade, course offerings, co-curricular opportunities, staffing levels and related educational priorities in order to maintain comprehensive instructional programs at all schools.

All Transfers - In addition to Permanent Design Capacity, other factors when determining space availability may include the combined capacity at educational center sites, number of students in a particular grade, course offerings, co-curricular opportunities, staffing levels and related educational priorities in order to maintain comprehensive instructional programs at all schools.
